ATHLETIC FIELD TERMS AND CONDITIONS			
<p>YOU MUST HAVE A PRINTED COPY OF THIS RESERVATION CONFIRMATION WITH YOU ON THE DAY OF YOUR RESERVATION IN ORDER TO USE THE FIELD. Reservation is for the exact times listed as no extra time will be given outside of the reservation time. In case of emergency/issues regarding locked fields or disruptive behavior, please call Park Rangers at (415) 242-6390. In case of general emergency please call 911.</p> <p>Single-use reservations made via the walk-up window or over the phone cannot be cancelled or changed. Advanced reservations made through a field request form can be cancelled or changed within 3 business days of receipt of an invoice. It is the responsibility of the Reservation Holder to carefully review the invoice and inform SF Rec and Park Permits &amp; Reservations staff of any changes or cancellations to the reservation otherwise you will be held responsible for the full payment of the invoice.</p> <p>Rainouts on grass fields will result in a credit, but you must call our office within 2 business days to request them. For multiple use reservations, see our reservations and policies. This reservation may be revoked or altered at any time for any emergency reason by the Recreation and Park Department. Locations, dates and times may be changed by the Department.</p> <p>Playability of Field (Rainout Status): Artificial turf fields play rain or shine except when there is lightning. The use of this reservation is subject to the playability of the field. Where conditions are questionable due to rain, playability must be confirmed before you use the field. Check our website at <a href="http://sfrecpark.org/permits-and-reservations/athletic-fields/rain-out-information/">http://sfrecpark.org/permits-and-reservations/athletic-fields/rain-out-information/</a> for the most up to date information. If a Department representative is on site, you must follow instructions.</p> <p>Activities on Field: Persons on fields must refrain from gambling, profane language, quarreling or consuming alcoholic beverages. Amplified sound and staking of any equipment is also prohibited. Reservation Holder may not charge admission, solicit monies, use a BBQ or sell food, beverages or merchandise without specific permits. Please contact (415) 831-5500 to obtain permits. You must follow the instructions of any Recreation and Park Department staff on-site regarding activities on the field.</p> <p>Cleanup: You are responsible for cleaning up all litter left on the field during your reserved time and taking your trash home with you off Department property. Failure to leave field litter-free may result in loss of future reservation privileges. If a previous user left garbage on the field, please let us know by calling 311.</p>			

Dogs: Dogs are not allowed on any athletic fields.

Liability for Use: The above named Reservation Holder agrees to reimburse any person (including the Department) who sustains property damage, such as broken windows, for the cost of that damage, where such damage occurs on public or private property when such damage is caused by the use of this facility. In addition to the Reservation Holder, the person who is representing the Reservation Holder agrees to be personally liable.

Indemnity: By acceptance of this Permit, Permittee agrees that it shall indemnify, defend and hold harmless the City and County of San Francisco, and its officers, agents, and employees, from and against any and all claims, losses, costs, liens, judgments, damages and liabilities of any kind (collectively, "Losses"), arising out of (a) any damage to any property, or death or injury to any person, including without limitation Permittee and its officers, agents, employees, and invitees, occurring on or about the permit area and relating in any manner to any use or activity under this Permit, (b) any failure by Permittee to faithfully observe or perform any of the terms, covenants or conditions of this Permit, or (c) the use of the permit area by Permittee, its officers, agents, employees or invitees; except to the extent that such Losses result directly from the gross negligence or willful misconduct of the City and County of San Francisco which are not contributed to by any act or omission of Permittee or its agents or invitees. The foregoing indemnity shall include, without limitation, reasonable attorneys' and consultants' fees, investigation and remediation costs and all other reasonable costs and expenses incurred by the indemnified parties. Permittee's obligations under this section shall survive the expiration or other termination of this Permit.

Waiver: (a) City makes no representations or warranties regarding the condition of the Permit Area, including but not limited to its suitability for the event proposed by Permittee, and Permittee accepts the Permit Area strictly on an "as is-with all faults" basis. Permittee has conducted its own investigation of the Permit Area to confirm its suitability for Permittee's intended use. City shall not be liable for any damage to, or for any bodily injury or death, resulting or arising from the condition of the Permit Area or its use by Permittee. (b) Permittee fully releases, waives, and discharges now and forever any and all claims relating to the Permit Area or this Permit, and covenants not to sue City, its officers and employees, and all persons acting through them, for any loss, harm or injury relating to Permittee's use of the Permit Area. (c) Permittee acknowledges that the above waiver and release includes all known and unknown, direct or indirect, and anticipated and unanticipated claims, and shall survive the expiration or termination of this Permit.

No Assignment or Transferring: This reservation may not be assigned or transferred. Violations of any of the above conditions will result in depriving the Reservation Holder of further use of facilities.

Special Rules for Athletic Fields (Grass and synthetic):

No Food: Eating food, drinking alcohol, chewing gum and sunflower seeds are prohibited on synthetic turf fields.

No Smoking or Barbeques: Fire of any kind is not allowed.

Stay Clean and Healthy: Wash your hands and any cuts, scrapes or turf burns after play.

No Bikes, Metal Cleats OR Golf: Bicycles, motor cycles, skateboards, rollerblades, metal cleats, sharp objects and golf play may tear the turf and are not permitted on the field.

Roll Goals: To move goals in place, roll them across the field using the wheels. Don't move goals alone or allow small children to move them. Dropping the wheels is a 2- person job. Watch your fingers!

Adhesives: Adhesives like tape and line markings will damage artificial turf and are prohibited without specific consent from Recreation and Parks.

Violations of any of the above conditions will result in depriving the Reservation Holder of further use of facilities and/or subject the Reservation Holder to fines via citations.

The Recreation and Park Department encourages park patrons to use alternative forms of transportation when visiting our facilities. Large groups and athletic teams are encouraged to car pool and ride share when possible.
